

Pershimco Buys Back 70% of Cerro Quema NSR

ROUYN-NORANDA, QUEBEC--(Marketwired - Aug 13, 2013) - [Pershimco Resources Inc. \(the "Company" or "Pershimco"\) \(TSX VENTURE:PRO\)\(FRANKFURT:BIZ\)](#) is pleased to inform its shareholders that it has repurchased 70% of all remaining net smelter royalties ("NSR") on the Cerro Quema project from a group of Panamanian entrepreneurs (CEMSA).

This purchase allows Pershimco to increase the net present value ("NPV") of the project, providing a higher return per share and a much stronger financial model. Specifically, Pershimco has repurchased a 1.4% NSR related to future gold and silver production, as well as a 2.45% royalty on copper and all other mineral production from the project's concessions, leaving only a 0.6% NSR on precious metals and 1.05% on other metals remaining privately held.

The Company has agreed to a purchase price of US \$2.5M over a period of 18 months, to be paid in instalments as detailed below, bearing a 6% annual interest rate.

"We feel that this represents an important investment in this project, particularly as our exploration work, including the promising results of our recent geophysical surveys, continues to increase Cerro Quema's potential. In line with our long term strategy, we are substantially increasing the overall value of the project as well as making the exciting deeper geological potential even more attractive," commented Alain Bureau, President and CEO of Pershimco.
