

Deep Well SAGD Steam Update

EDMONTON, ALBERTA--(Marketwired - May 6, 2014) - Deep Well Oil & Gas, Inc. (and its subsidiaries - "Deep Well" or "Company") (OTCQB:DWOG) wishes to announce that the SAGD steam plant and water handling facility is mechanically complete and has been turned over from the Construction Management Team to Operations for start-up. We have been informed by the operator that the first start-up steam circulation phase to establish communication between the injector well and the producer well is imminent.

The leases cover 17,408 gross hectares (43,015 gross acres) of land.
