

TORONTO, ONTARIO--(Marketwired - Sep 15, 2015) - [Minsud Resources Corp.](#) (TSX VENTURE:MSR) ("Minsud" or the "Company") is pleased to announce the second closing of a non-brokered private placement offering of 5,780,000 units of Minsud (the "Units") for gross proceeds of \$578,000 (the "Private Placement"). As a result, aggregate gross proceeds from the Private Placement - initially announced on August 13, 2015 for \$ 2,000,000 at \$0.10 per unit - now total \$1,890,478. Minsud had previously announced, on August 20, 2015, the receipt of gross proceeds of \$1,312,478 from the first closing of the Private Placement.

Each Unit consists of one common share in the capital of the Company (the "Shares") and one common share purchase warrant (the "Warrants"). Each Warrant is exercisable into one Share at \$0.35 until September 15, 2017, provided that in the event that the 20 day closing price of the Shares on the TSX Venture Exchange or such other stock exchange that the Shares may be then listed on is greater than \$0.35, the Company shall be entitled to accelerate the exercise period of the Warrants to a period of not less than 10 days after written notice is deemed to have been received by the holders of the Warrants from the Company regarding same.

The net proceeds will be used primarily for a 5,300 meter HQ drilling program and related investigations, focusing mainly on outlining the Chita Porphyry Cu-Mo-Ag-Au deposit. In addition the funding will cover option and permitting payments for various properties, as well as working capital and corporate overhead requirements.

The securities issued in connection with this second closing of the Private Placement will be subject to a four month hold period expiring on January 16, 2016. No commission or finder's fee was paid in connection with the Private Placement.
