[Sama Resources Inc.](#)/Ressources Sama Inc. (TSX VENTURE:SME) (the "Corporation" or "Sama") is pleased to announce the closing of the non-brokered private placement (the "Private Placement") announced on May 9, 2016. The Corporation has issued a total of 6,550,500 units of Sama ("Units") at a price of \$0.10 per Unit for gross proceeds of CAD\$655,050.

Each Unit was comprised of one common share (a "Common Share") in the capital of the Corporation and one common share purchase warrant (a "Warrant"). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.15 per share for a period of 60 months from the closing date of the Private Placement.

The Corporation paid a cash commission of \$10,850 and issued 178,500 broker warrants to purchase Common Shares exercisable at a price of \$0.15 per Common Share for a period of 60 months in connection with the closing of the Private Placement.

The Private Placement is subject to certain conditions including, but not limited to, the receipt of all necessary approvals, including the final approval of the TSX Venture Exchange. All securities issuable pursuant to the Private Placement are subject to a four month hold period from the date of issuance in accordance with applicable Canadian securities laws.

The Corporation intends to use the net proceeds of the Private Placement for exploration, working capital and general and administrative purposes.
