Vancouver, June 7, 2017 - [Cardiff Energy Corp.](#) (the "Company") (TSX-V: "CRS", Frankfurt: "C2Z.F", US Pinksheets: "CRRDF") announces that it has cancelled a total of 314,285 post consolidation (incentive stock options ("Options"), that were granted under the Corporation's stock option plan to certain officers and directors of the Corporation. The cancelled options were originally granted on September 28, 2015 with an exercise price of \$0.145 per common share and on November 20, 2015 with an exercise price of \$0.165 per common share. Following the cancellation of the Options, the Corporation has 342,850 Options outstanding.

The Company would also like to announce the resignation of Derek Stonehouse as a Director and VP of Exploration and thank him for his contributions.
