

# Newlox Gold Ventures Corp. Reports 370% Quarter-Over-Quarter Revenue Growth

Vancouver, 16 December 2019 - [Newlox Gold Ventures Corp.](#) (CNSX:LUX.CN) (Frankfurt:NGO) ("Newlox" or the "Company") published financial statements for the second quarter of fiscal 2020. Management reports that sales revenue increased 370% quarter-over-quarter as a result of increased efficiencies at Newlox's first artisanal tailings reclamation and precious metals recovery facility in Central America. Management expected this result as Newlox's operations team has been executing its plan to ramp-up production at the facility.

From the start of commercial operations in June of 2019, Newlox has carefully increased throughput and improved efficiency. The operations team achieved production goals by re-investing operational revenue to facilitate incremental organic growth at Project One and intends to expand Newlox's environmentally and socially positive business model to additional targeted projects.

## Recent News

- - Newlox recently shared a video demonstrating the operation of its in-house analytical laboratory. The on-site laboratory has both fire-assay and atomic absorption capabilities, allowing for the sampling and assaying of both solid and liquid samples for precious metals. The lab enables strict control of feed grade, operational parameters, and metals produced.
- - Newlox marked four months of continuous gold production on October 8, 2019 and shared a second video of gold dore being poured at the environmental remediation and precious metals production facility.
- - Newlox posted a video demonstrating one of the many regular gold dore pours during the summer.
- - Newlox established steady-state operations in June, as announced July 9, 2019
- - The Company announced completion of pre-production activities on May 27, 2019.

Newlox has signed agreements with local artisanal mining cooperatives to provide both a steady supply of historical tailings and a newly created feedstock for its first fully operational processing plant in Central America.

With hundreds of years of mining history in Latin America and inefficient artisanal processing continuing to this day, the Company has identified and secured a compelling opportunity to grow its business model. Newlox has identified a niche within the extractive industry where a clean-technology company can apply innovative processing techniques to recover not only precious metals but also affect positive change in the environmental and social landscape in its targeted jurisdictions of operations.
