Brossard, Feb 1st, 2021 - [Nippon Dragon Resources Inc.](#) ("Nippon" or "NDR") (TSXV:NIP) reports that Mr. Donald Brisebois has initiated a lawsuit against [Nippon Dragon Resources Inc.](#) for wrongful dismissal and unpaid wages. He is also demanding that the Court issue a sublicense to him allowing him to use a technology which he claims was developed by him in the early 2000s.

[Nippon Dragon Resources Inc.](#) denies the merits of the demands and allegations of Mr. Brisebois.
