CALGARY, Dec. 17, 2021 - [North Peak Resources Ltd.](#) (TSXV: NPR) (the "Company") announces the grant of incentive stock options to acquire a total of 200,000 common shares of the Company at an exercise price of \$1.90 per share, with such options to vest as to one-half immediately and the remaining one-half on the first-year anniversary of the date of grant. The options expire five years from the date to grant. These options were granted to directors and officers of the Company.
