

Soma Gold Announces That The Union Representing Employees In El Bagre, Antioquia, Colombia Have Elected To Strike

VANCOUVER, Sept. 20, 2022 - [Soma Gold Corp.](#) (TSXV: SOMA) (WKN: A2P4DU) (OTC: SMAGF) (the "Company" or "Soma") announces that the unionized employees at the Company's Operadora Minera SAS subsidiary have elected to go on strike, effective immediately. Work at the site stopped on Friday, September 16th, 2022. Negotiations continue, and both parties have expressed hope that a resolution can be found quickly. The Colombian Ministry of Labor is assisting in mediating a settlement.
