VANCOUVER, Sept. 29, 2022 - Zacapa Resources Ltd. (TSXV: ZACA) (OTCQB: ZACAF) (DE: BH0) ("Zacapa") is pleased to announce a non-brokered private placement (the "Offering") for the sale of up to 20,000,000 units (the "Units") at a price of C\$0.15 per Unit for gross proceeds of up to C\$3,000,000. Each Unit will be comprised of one common share (each, a "Unit Share") and one common share purchase warrant (each, a "Warrant"). The net proceeds from the sale of Units will be used for exploration and drilling of Zacapa's projects, including the South Bullfrog gold project in Nevada and the Miller Mountain gold project in Idaho, and for working capital and general corporate purposes. Finder's fees will be payable in accordance with the policies of the TSX Venture Exchange.

The closing of the Offering is expected to occur on or about October 7, 2022 and is subject to receipt of all necessary regulatory approvals including the TSX Venture Exchange. The Unit Shares, Warrant Shares and any common shares that are issuable from any finder's warrants will be subject to a hold period of four months and one day in accordance with applicable securities laws.
