BULGOLD Announces Refiling of First Quarter Financial Results for Three Months Ended March 31, 2023

TORONTO, May 26, 2023 - <u>Bulgold Inc.</u> (TSXV: ZLTO) (the "Company" or "BULGOLD") announced that it has refiled its unaudited condensed interim financial statements and MD&A for the first quarter ended March 31, 2023. It was determined that a subsequent note should be added to the financial statements and MD&A regarding the Company's non-brokered private placement which was announced on May 11, 2023 (the "Offering").

The Offering is for gross proceeds of up to \$3,500,000 from the sale of units of the Company (each, a "Unit") at a price of \$0.30 per Unit (the "Issue Price"). Each Unit will consist of one common share of the Company (each a "Unit Share") and one-half of one common share purchase warrant (each whole common share purchase warrant, a "Warrant"). Each Warrant shall entitle the holder to purchase one common share of the Company (each, a "Warrant Share") at a price of \$0.40 at any time on or before that date which is 18 months after the closing date of the Offering. The Offering is expected to close on or about June 14, 2023.

Management of the Company believes that its assets show potential for high-grade, good-metallurgy, low-sulfidation epithermal gold mineralisation. The Company also holds an option to acquire a 100% interest in the Lutila exploration licence located in central Slovakia which is prospective for low-sulfidation epithermal gold mineralisation.

BULGOLD had approximately \$1.6 million in its treasury at March 31, 2023. BULGOLD's issued and outstanding share capital totals 20,231,100 common shares, of which approximately 49.6% is held by Founders and Management.
