Westmount Mobilizes Exploration Team to Kaba Lithium Property

Vancouver, July 13, 2023 - <u>Westmount Minerals Corp.</u> (CSE: WMC) ("Westmount" or the "Company") is pleased to announce it has mobilized an exploration team to the Kaba Lithium Property (the "Property") in Northwestern Ontario. The team has commenced reconnaissance mapping and sampling and has confirmed multiple pegmatite outcroppings and lithium mineral indicators.

The well-known Georgia Lake Lithium-pegmatite field is located just west of the Property. Within the pegmatite field, Rock Tech Lithium Inc. has completed a Pre-Feasibility Study (NR-November 16, 2022) stating its Georgia Lake property has 10.6 million tonnes (mt) of Indicated Mineral Resources grading 0.88% Li₂O and 4.22 mt of Inferred Mineral Resources at a grade of 1% Li₂O (NR- March 7, 2023). Other companies with lithium mineralization prospects include Imagine Lithium Inc. and Ultra Lithium Inc. (Map 1)

David Tafel, CEO and Director commented: "Our geological team has commenced a sampling program after confirming the presence of multiple pegmatite outcroppings as well as lithium indicator minerals as reported in historical government reports. Early indications are validating the potential we see for the Kaba Property. While there is significant work to be done, initial exploration is encouraging and underscores its strategic location in the Georgia Lake pegmatite area."

Qualified Person

and Pilot East Lithium Properties located near Ear Falls, Ontario. The Properties are just south of Green Technology Metal's (ASX listed) expanding Root deposit.

The Company has also advanced the Douay East gold property located within the greater Abitibi Greenstone Belt region in Quebec to the drill-ready stage.
