WINNEMUCCA, Oct. 4, 2023 - <u>Hycroft Mining Holding Corp.</u> (Nasdaq: HYMC) ("Hycroft" or "the Company") announces that, as anticipated, today it received a notice from Nasdaq indicating the Company's shares would be delisted on October 12, 2023, due to non-compliance with Nasdaq's minimum bid price requirement as set forth in Nasdaq's Listing Rule 5550(a)(2). However, the delisting process will be stayed and the Company's stock will continue to trade if the Company requests a hearing before the Nasdaq Hearings Panel (the "Panel") no later than October 10, 2023. The Company intends to file its hearing request on October 9, 2023. Further information about this process can be found at https://listingcenter.nasdaq.com/.

The Company is diligently working to regain compliance with the minimum bid price requirement and will provide an update when relevant information becomes available.

Hycroft Mining Holding Corp. is a US-based gold and silver company developing the Hycroft Mine, one of the world's largest precious metals deposits located in northern Nevada, a Tier-One mining jurisdiction. After a long history of oxide heap leaching operations, the Company is focused on completing the technical studies to transition the Hycroft Mine into a large-scale milling operation for processing the sulfide ore. In addition, the Company is engaged in a robust exploration drill program to unlock the full potential of our expansive +64,000-acre land package, of which only 10% has been explored.
