

Flying Nickel Closes Private Placement for Proceeds of \$600,705 with Norway House Cree Nation as Minago's Strategic Partner

Vancouver, October 16, 2023 - [Flying Nickel Mining Corp.](#) (TSXV: FLYN) (OTCQB: FLYNF) ("Flying Nickel" or the "Company") is pleased to announce that it has closed a non-brokered private placement offering ("the Offering") of 7,603,862 common shares of the Company previously announced on August 23, 2023, raising gross proceeds of \$600,705. The Offering was priced at \$0.079 per share.

Norway House Cree Nation ("NHCN") was the sole investor and is a strategic partner to Flying Nickel. The Company's flagship Minago nickel project is in NHCN's exclusive traditional territory.

No finders fees were payable in connection with the Offering. The securities issued as part of the Offering are subject to a regulatory hold period expiring on February 13, 2024.

Proceeds of the Offering are will be used for exploration and general working capital.
