

# PJX Resources Announces Amendment to Recently Completed Non-Brokered Private Placement

TORONTO, December 7, 2023 - [PJX Resources Inc.](#) announced on November 22, 2023, that it had closed a non-brokered private placement and, subject to TSXV Exchange approval, Finders' fees of \$30,337.20 cash and 291,709 Finders' Warrants would be paid in relation to the completion of the Offering. The TSXV Exchange has since approved the amount be amended to total Finders' Fees of \$39,331.20 cash and 385,309 Finders' Warrants respectively. All other details of the private placement are unchanged.
