## Palisades Goldcorp Ltd. Announces Closing Of \$2.5 Million Non-brokered Private Placement

Palisades Goldcorp Ltd. (TSXV: PALI) ("Palisades" or the "Company") announces the closing of its previously announced non-brokered private placement financing (the "Non-Brokered Private Placement"). The Company has issued 1,436,365 common shares of the Company (the "Shares") at a price of \$1.74 per Share for aggregate gross proceeds of \$2,499,275. The Shares were issued to a significant shareholder, an insider of the Company, and no finder's fees were applicable.

Proceeds from the Non-Brokered Private Placement will be used for general working capital purposes. The Shares issued in connection with the Non-Brokered Private Placement are subject to a statutory hold period expiring July 5, 2025, being the date that is four months and one day from the date of issuance, in accordance with applicable securities legislation. The Non-Brokered Private Placement is subject to final acceptance by the TSX Venture Exchange.

An insider of the Company participated in the Non-Brokered Private Placement by purchasing the Shares. The participation by the insider constitutes a "related party transaction" as defined under Multilateral Instrument 61-101 Protection of Minority Security Holders in Special Transactions ("MI 61-101"). The Company relied on the exemptions from the valuation and minority shareholder approval requirements of MI 61-101 contained in sections 5.5(a) and 5.7(1)(a) of MI 61-101, as neither the fair market value of the securities purchased by the insider, nor the consideration for the securities paid by such insider, exceeded 25% of Palisades' market capitalization. The Company did not file a material change report in respect of the related party transaction at least 21 days before the closing of the Non-Brokered Private Placement, which the Company deems reasonable in the circumstances in order to complete the Non-Brokered Private Placement in an expeditious manner.
