Sterling announced drill results of 262.5 metres of 1.05% copper equivalent. The Company also announces that it has completed a drone mag survey over the Mount Jamie claims in Red Lake, Ontario. The primary goal of this survey was to identify the mineral potential of these claims, and the Company expects results to be issued in the near future.

The Company also announces that it has granted 1,600,000 incentive stock options ("Options") pursuant to the Plan to directors and officers of the Company. Each Option is exercisable into one common share of the Company at an exercise price of \$0.05 for a five-year term expiring on October 3, 2030.
