

Cornish Metals Announces Exercise of Stock Options and Issue of Equity & PDMR Dealings

VANCOUVER, Oct. 15, 2025 - [Cornish Metals Inc.](#) (AIM/TSXV: CUSN) ("Cornish Metals" or the "Company"), a mineral exploration and development company focused on advancing its wholly owned and permitted South Crofty tin project in Cornwall, United Kingdom, announces that Non-Executive Chairman, Mr Patrick F. N. Anderson, has exercised 750,000 options over common shares (the "New Common Shares") in the Company at an exercise price of 10 cents per common share for an aggregate consideration of C\$75,000 (equivalent to £40,079).

Following this purchase, Mr Anderson has a beneficial interest in 1,425,271 common shares representing 0.11% of the issued share capital in the Company.

The New Common Shares will rank pari passu with the existing shares and application has been made for the 750,000 New Common Shares to be admitted to trading on AIM ("Admission"). It is expected that Admission will become effective and dealings in the New Common Shares will commence at 8:00am on or around October 20, 2025. The New Common Shares will also trade on the TSX Venture Exchange.

Following Admission, Cornish Metals' Issued and Outstanding share capital will consist of 1,254,501,619 common shares. The Company does not hold any common shares in treasury. Shareholders may use this figure as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company.

- would be the only primary producer of tin in Europe or North America. Approximately two-thirds of the tin mined today comes from China, Myanmar and Indonesia;
